Nomination papers for these elections may be obtained from the Returning Officer at the offices of Cotswold District Council, Trinity Road, Cirencester, Glos, GL7 1PX, on any working day (excluding bank holidays) Monday to Friday between the hours of 9 am and 5 pm. The Returning Officer will, at the request of an elector, prepare a nomination paper for signature.
- 2. Completed nomination papers must be delivered by hand to the Returning Officer, at the offices of Council District Council, Trinity Road, Cirencester, Glos, GL7 1PX on any working day (excluding bank holidays) after the date of this notice between the hours of 9 am and 5 pm until Tuesday, 2 April and between the hours of 9 am and 4 pm on Wednesday, 3 April 2019. Completed nominations must be delivered by no later than 4 pm on Wednesday, 3 April 2019.
- If any election is contested the poll will take place on Thursday, 2nd May 2019.
- 4. Applications to register to vote must reach the Electoral Registration Officer at the offices of Council District Council, Trinity Road, Cirencester, Glos, GL7 1PX by 12 midnight on Friday 12 April 2019. Applications can be made online: https://www.gov.uk/register-to-vote.
- 5. Applications for, amendments to or cancellations of postal votes and amendments to or cancellations of proxy votes must reach the Electoral Registration Officer at the offices of Council Offices, Trinity Road, Cirencester, Glos, GL7 1PX by 5 pm on Monday, 15 April 2019.
- 6. New applications to vote by proxy must reach the Electoral Registration Officer at the offices of Council District Council, Trinity Road, Cirencester, Glos, GL7 1PX by 5 pm on Wednesday, 24 April 2019.
- 7. Applications to vote by emergency proxy on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the offices of Council District Council, Trinity Road, Cirencester, Glos, GL7 1PX by 5 pm on Thursday, 2 May 2019. The physical incapacity must have occurred after 5 pm on Wednesday, 24 April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 24 April 2019.
