Cllr Richard Williams reported on the meeting held with the Gloucestershire Highways Officers, in which some improvements and amendments were recommended.

Summary:

- The Independent Safety Audit Report was in support of Double Yellow lines along the narrow end of Cemetery Lane and in a small area of Church Road.
- The wider end of Cemetery Lane to have marked parking bays.

- Two new Disabled Bays to be created in Church Road and the proposed area for double yellows is to be reduced.
- Time Parking restrictions to be increased from 2 hours to 3 hours for the whole of the scheme (where time parking restrictions have been proposed).
- Creation of a small loading bay by the Post Office/Tea Rooms in The Street.
- The Police and Highways also recommended installing double yellow lines along the stretch of B4425 from Arlington Fields towards Arlington Green (on the side of Arlington Fields only).

The next steps are for the amendments to be drawn up in the proposals and a copy sent to the Parish Council. Gloucestershire Highways will then consult with the Statatory Consultees and issue a letter drop consulation to household in Bibury. The consultation will be for at least 21 days and the responses will be considered before a formal consultation is carried out.

Cllr John Phillips requested that they also look at the issues of parking along Lower Ablington Road.
