You are allowed to combine CIL monies received over a longer period to save up for a larger project, however they must be spent within 5 years of receipt; any unspent monies will need to be returned to the District Council. A report template for any expenditure made in 2024/25 will be provided at the start of the next financial year, to ensure you comply with the reporting criteria in the CIL legislation. If you would like me to enquire as to any CIL payments in your parish, please let me know.

Community Emergency Plans

How would you prepare for an emergency?

I referred to this in my October report. In a newly launched website, the government is encouraging people to think about what they would do if they and those around them were exposed to risks ranging from floods to fires to power cuts.

The website provides simple and effective steps people can take to be more prepared, at gov.uk/prepare. Taking action in advance will make it easier to manage an emergency if it does happen.

Five simple things you can do now:

- 1. Find out if you are eligible to sign up to your gas, electricity and water supplier's <u>Priority Service Registers</u>, so companies know that you need additional support.
- 2. Set a reminder in your phone or make a note on your calendar to check your smoke alarm once a month.
- 3. Write down important phone numbers on paper such as the number to report a power cut (105) and the numbers of anyone you might want to contact in an emergency.
- 4. Talk to your children about how and when to call 999 and what they should do if there's an emergency, such as a fire at home.
- 5. Check your long term flood risk and sign up for flood and weather warnings.

A417 MISSING LINK PROJECT UPDATE

A436 Air Balloon Roundabout to Ullenwood Manor Road overnight closures

Monday 4 November to Saturday 9 November 9pm to 6am - The A436 will be closed in both directions from the Air Balloon Roundabout to the Ullenwood Manor Road to undertake the

installation of permanent drainage and gullies, installation of kerbs, surfacing and ducting works. This work is part of the A417 Missing Link scheme.

Barrow Wake car park closure

Barrow Wake viewpoint car park will remain closed until March 2025. This is so that we can build a new dry-stone wall to stop glare from vehicle lights and to allow for the installation of drainage tanks under the carriageway.

A417/A419 essential maintenance

The five weekend closures recently advertised to complete essential maintenance work on the A417 and A419 are now completed. This was separate from the A417 Missing Link scheme.

Family Farm Tax

The APR change in the budget means that inheritance tax of 20% will effectively apply on the full value of farms and rural estates above £1m.

The proportion of income spent on food in the UK has halved over the past 60 years. In 1957, 33% of total spending went on food, in 2022 the average household spent 11.8% of their income on food. Food prices have come down, and so has farmers' income.

The Coln Valley is a rural, agricultural ward, farming food for the nation does not pay the bills. Most farmers find creative ways to stay afloat by doing two or more jobs, or starting up a sideline business as they make little income from the one they work long, lonely hours for, providing food.

Farmers tend to be asset-rich and cash poor. Farming is not a popular vocation due to the low pay, difficult work and increasing risk of having crops ruined by extreme weather. Farming is like nursing, it is a vocation, often handed down from father to son or daughter. If they cannot afford to pass their business down to relatives, the family farm will die out, along with localised knowledge - every farm is unique having different topography, soils, weather exposure etc. and food security will decline.

Family farmers are caretakers of our landscapes, the countryside would look completely different without them.

A sobering thought: Anna Daroy, Chief Executive of BACP (British Association of Counsellors and Psychologists) said in September 2023 that even before the cost-of-living crisis, male farm workers were three times more likely to take their own lives than the national male average and that the UK government's mental health supports for rural communities are not enough as "much more is needed to recognise the on-going impacts of the cost-of-living crisis alongside other factors such as Covid-19, Brexit, the war in Ukraine, farm succession, and labour shortages".

PLEASE! NEVER PUT BATTERIES IN YOUR GENERAL WASTE

Recycling operators and vehicles could be put in real danger.

A 2021 study claims that Li-ion batteries cause about 48% of all UK waste fires per year, resulting in millions in damage to waste operators, fire services and the environment. Recycling centres are full of combustible materials and too many 'zombie' batteries are going into either recycling bins or black rubbish bags, even small lithium-ion batteries explode "with a rocket flame" if punctured. The ESA has launched a campaign called Take Charge which encourages people to dispose of batteries properly.

How can you help fight the zombies?



Never put a battery in the bin



Take batteries out of electricals (phones, vapes, cameras etc.) before recycling



Always use the right recycling facilities for batteries. Check waste wizard



if you aren't sure.
